Oakshire Elementary School will encourage parents to become meaningfully involved and promote capacity for strong parental involvement in the following ways:

• The school offers a flexible number of meetings-mornings or evenings to keep parents informed of current events and issues.

• The school provides parents with timely information about school programs; progress reports, and parent/teacher conference times to discuss their child's progress.

• The school provides parents a description and explanation of the curriculum the school uses, forms of academic assessment used to measure student progress, and the proficiency levels students are expected to meet.

• Materials and training are provided to help parents work with their children to improve their achievement, such as literacy training and using technology to foster parental involvement.

• Parental involvement strategies are coordinated and integrated with parent involvement strategies under other programs, such as Head Start, Early Reading First, Even Start, Parents as Teachers, Home Instruction Program for Preschool Youngsters, Stan=run preschool programs, and Title III language instructional programs.
