

Algebra I | A1

Algebra I emphasizes linear and quadratic expressions, equations, and functions. This course also introduces students to polynomial, rational and exponential functions with domains in the integers. Students explore the structures of and interpret functions and other mathematical models. Students build upon previous knowledge of equations and inequalities to reason, solve, and represent equations and inequalities numerically and graphically.

The major work of Algebra I is from the following domains and clusters:

Geometry | G

Geometry emphasizes similarity, right triangle trigonometry, congruence, and modeling geometry concepts in real life situations. Students build upon previous knowledge of similarity, congruence, and triangles to prove theorems and reason mathematically. This course also introduces students to geometric constructions and circles. Students show a progression of mastery and understanding of the use and application of surface area and volume.

The major work of Geometry is from the following domains and clusters:

- **Congruence**
 - Understand congruence in terms of rigid motions.
 - Prove geometric theorems.
- **Similarity, Right Triangles, and Trigonometry**
 - Understand similarity in terms of similarity transformations.
 - Prove theorems involving similarity.
 - Define trigonometric ratios and solve problems involving triangles.
- **Expressing Geometric Properties with Equations**
 - Use coordinates to prove simple geometric theorems algebraically.
